#### Wales Synod – Introduction to the Annual Report for 2019-20

I am pleased once more to introduce this Annual Report for the Wales Synod for the year 2019-20.

Since March of this last year, the work and witness of the Wales Synod, like so much of the church and wider society as a whole, has been profoundly affected by the spread of the Coronavirus and the consequent restrictions. This has had a significant impact on the ability of local churches to meet for worship and fellowship and to serve their local communities, not least in the provision of premises for activities and events. I have been hugely impressed by the way that colleagues lay and ordained have worked together to address these challenges: providing printed and 'online' services; making alternative arrangements for pastoral support; and undertaking risk assessments concerning the safe use of church premises, most of which have had to be closed for some significant periods of time. I also pay tribute to Synod colleagues and officers who have adjusted to new patterns of working and meeting remotely (not least through use of 'Zoom' technology) and finding ways to ensure that the business of the Synod can continue, even if the restrictions have meant that we have had to defer for a time.

We recognise that these restrictions will have affected the finances of local churches and circuits, as worship services and collections have been unable to take place as usual; and also that income from lettings has fallen as church premises, like other community centres, have had to close to all but 'essential' public services. We recognise that this may be offset to some extent by reductions in cost of travel to meetings and running premises, but we nevertheless anticipate this may have a serious impact on the finances of local churches and circuits going into this next year 2020-21. Accordingly and we have begun to explore ways in which the Synod may use some of its reserves to help ease the burden on some circuits where the pressures may be particularly acute.

Despite all these challenges, the Synod has sought to continue its ministry and mission in line with the priorities of the Synod Development Plan. This Plan, incorporating the Synod Mission statement, commits us to supporting the work and witness of circuits across Wales, and during 2019-20 we have sought to do this in a number of ways. In the first place we have continued to respond to applications for support from the Synod Advance Fund with grants totalling £329,453, more than doubling the amount in the previous year. Once again in this last year the majority of this, some £175,878, went to Ministry projects rather than Property schemes, but in line with the Scheme & Grants Committee recommendation to increase the maximum amount of Synod grant support available for major new property schemes, we were for example able to make a significant grant towards the new Barry Waterfront Uniting Church which we anticipate opening in the spring of 2021. Secondly, we seek to resource circuits by the provision of ordained ministry through the connexional Stationing process. We were able to fill all 3 of our appointment in the Stationing for 2020, and have so far managed to fill 5 out of 6 appointments in the Stationing process for 2021. However, although we anticipating welcoming the ordination of Probationer colleagues at both the 2020 and 2021 Conferences, we have not managed to encourage new candidates for ministry to offer in these last 2 years. So we know that the challenge of recruiting and providing ministry remains, and that we must continue seeking the most effective way to deploy our ministers and make use of their giftings.

Thirdly, we look to support circuits as they seek to reshape themselves for mission. As noted above, the Coronavirus restrictions have profoundly impacted some of our mission planning. The anticipated Youth Exchange to America has had to be postponed again, and some of the new mission projects outlined in previous reports have had to be re-shaped or taken on in new ways. But equally churches and circuits have been finding that 'on-line' forms of worship and fellowship have enabled new ways of making contact with people, and the Synod Schemes & Grants Committee has sought to make a new grant stream available to support churches and circuits in developing their online presence.

We remain firmly part of a Connexional church, and one of our last events before the lockdown in March was to host a visit from the President & Vice-President of Conference in February, when they shared in a 'Big Day Out' with Momentwm, story-telling events in north Wales, a trip to the Amelia Farm in the Vale of Glamorgan, and finished with a bilingual Communion service in Aberystwyth.

This joint event with Synod Cymru is important also because it reminds us of our commitment in the Development Plan to work more closely with colleagues in Synod Cymru. Following the mission audit undertaken in autumn 2019, we had been waiting for Synod Cymru to decide on the options this presented. Unfortunately, their Spring Synod was postponed because of the virus, but meeting in November 2020, they voted in favour of 'option 1', seeking to come as a welsh-speaking circuit into a new or re-shaped Wales Synod. So currently we are resuming more detailed conversations in light of that decision, with a view to presenting some outline proposals to both Spring Synod(s) in 2021.

The impact of the Coronavirus continues to remind us that there are still many uncertainties ahead. We were pleased to welcome our new Synod Safeguarding Officer Rhian Evans-Hill in October, but very conscious that so much of her induction had to be carried our remotely rather than in person. As I write this report I'm conscious that the Synod Office is closed, and that Wendy and I, like so many others across the country, are working from home to ensure that Synod business is properly dealt with. But I trust that the reports in this book still encourage us, as across Wales we seek to live out 'Our Calling' as disciples of Jesus and respond to the 'Priorities' of the Methodist Church.

#### Synod Policy Committee

2020 has been a difficult year for all, learning to live with Corvid-19 has had an impact on all our lives. SPC is no different – we met face to face in March (having had to delay the meeting planned for February due to adverse weather) and our further two meetings in June and October were carried out virtually via Zoom meetings. Interestingly, SPC have decided that all future meetings will be carried out virtually using Zoom rather than meeting face to face. This saves travel time and also costs associated with travel. SPC will monitor this planned change, but do not anticipate moving away from virtual meetings.

To ensure the meeting covers all aspects of business required, a standard agenda is used with key topics:

Implementing Synod Policy, Chair's business, PC's business, Matters to and from related bodies, Ecumenical matters and Ministry matters.

Such a model ensures the meeting covers all matters throughout the year.

During the 2020, a varied and comprehensive list of topics have been addressed and as appropriate, decisions made within the responsibility of the meeting.

Key items have included:

- Finance scrutiny of the Synod's finances, including approving budgets and annual accounts, approval of the Synod Reserves Policy and overseeing finances linked to Trust 14508
- Reviewing Synod policy agreeing a revised policy regarding Local Preacher's extension of period on trial. Confirming a plan to enable Circuits to withhold for a short period the Wales Synod assessment payments if they so wish, thus assisting financially in a difficult year brought on by the pandemic we are living through
- Lay Membership of Synod annually approving the lay membership of Wales Synod
- Property related matters including agreeing a funding package for the development of Barry Uniting Church a new church development in the Waterfront area of Barry
- Manses receiving a report from the Synod Manses Committee ensuring all manses are fully fit for purpose

- Sabbaticals approving all requests for sabbaticals and receiving reports from those who have taken a sabbatical
- Call to Prayer monitoring the successful progress of this project ase ach Circuit took responsibility for this programme
- Closure of churches approving Circuit requests for churches to cease worship and approval for sale of such buildings.
- Stationing assisting the Chair in this very important aspect of work undertaken annually
- Methodist Council receiving reports from Wales Synod Methodist Council and considering any topics referred for consideration through the connexion – e.g. 'Reaffirming Our Calling: Trustee Structure',' Marriage and Relationship' Methodist Conference – receiving feedback reports from those who attended
- Y Cyngor Maintaining an active interest in the work of Y Cyngor, particularly related to the ongoing conversations between Synod Cymru and Wales Synod regarding the future plans for the organisation and delivery of Methodism in Wales.
- Ecumenical Maintaining active interest in matters from/for the Methodist/ URC Joint Liaison Group and receiving reports related to Christian Aid -Wales

The above aims to give a flavour of the work of SPC through the year, carrying out Synod policy. The membership of SPC has representatives from each Circuit in Wales and it is each circuit's responsibility to annually appoint their member. The meeting has been well attended and now meeting virtually early morning to travel to Newtown (our former meeting venue) in no longer part of being a member, a bonus for some of SPC's !

Each Circuit representative is expected to report back items from SPC to their Circuit and all are welcomed to place items on the agenda. The dates of SPC for 2021 will printed in the annual Synod Handbook. Items with relevant papers should be with the Assistant Synod Secretary not later than four weeks before SPC meets to ensure their inclusion on the next appropriate SPC agenda.

As vacancies occur, Circuits may wish to consider appointing more women and lay representatives. We look forward to continued developments linked to Methodism in Wales and potential new ways of being church.

Looking forward, Rev Dr Stephen Wigley will be taking a sabbatical from 1<sup>st</sup> March to 7<sup>th</sup> June 2021, with a short break when he will return to work from 18-25<sup>th</sup> April 2021. This is to enable Stephen to chair the key Synod meeting in April 2021. At this meeting Wales Synod will respond both to the 'God in Love units us' report and also to the outcome of Synod Cymru decision regarding their future and the potential outcome for Wales Synod and for Methodism in Wales, both key topics in our lives as Methodists.

## Synod Schemes and Grants Committee Report 2019/2020

To say that it has been a difficult year for all churches is to state the obvious. Many of the mission grants were to support the employment of staff members to enable congregations to carry out proposed mission projects. Due to the COVID19 pandemic and restrictions some staff members were placed on the UK Government furlough scheme whilst other carried out activities other than planned online. In other Circuits recruitment has been delayed. There has been a small increase in the ministry and mission grants paid this year. The majority of which are ongoing support to Circuits to enable ministry and mission to continue, as well as chaplaincy support to our higher education institutions. Ministry Grants totalled £ 175,877.99. The difficult circumstances of the year possibly reduced the number of requests for small mission projects.

After an initial halt to building and renovation work, over the summer much more work was able to be conducted, enabling projects to progress. As anticipated at the end of last year, there has been an increase in building grants made. A significant grant of £70k was made to the Bridgend Uniting Church Redevelopment project which was agreed as match funding for significant grant enabling this £1.25m project to go ahead. Other major projects have not been progressed as far as might have been anticipated, so some potential requests for significant sums for major church building works have been delayed. A total of £153,574.60 paid out for building projects.

#### Synod Property Report

A Panel of Surveyors contracted by TMCP is now in operation. This panel complements the Panel of Solicitors which is operating satisfactorily with generally good comments from around the Synod. Some Managing Trustees have had difficulty in appointing a surveyor to carry out quinquennial inspections and this new panel will go some way in alleviating that problem. The panel lists can be accessed on TMCP's web site.

This year there has been an increase in the number of circuits and churches who have completed their returns. Eight out of fifteen were complete or almost complete. I urge those circuits and churches who do not complete their returns to do so. Managing Trustees may feel that I am badgering them when I send out reminder emails but it is a requirement of Standing Orders 941 and 953 that this be done.

#### Learning Network – Cymru |Wales

2019-20 was definitely a year of two halves. In the autumn, we carried on as we had before, providing training and support in person across both Synods. We supported safeguarding training at every level, from being part of the connexional group rewriting the Foundation Module course, to supporting the Synod Safeguarding Officers in delivering the Advanced module, and filling in as additional trainers in circuits that needed support in delivery. We ran courses on the role of the Circuit Steward, helped to facilitate the training of ministers as supervisors, delivered the Theology Unwrapped course, travelled to Cliff College to help train One Programme Participants, and led training for ministers and lay workers in MBTI. We supported tutors of the Worship: Leading and Preaching course, and moderated completed portfolios. We facilitated training for those leading Marriage and Relationships conversations; and continued to support the Synod Cymru audit and the follow up ready for the vote in Synod in the spring of 2020. We helped plan and lead the 3Generate event for young people across the connexion, and Gareth extended that work by developing a theology of physicality for people of all ages. We supported the work of Momentum and providing training to youth workers in preparation for the Big Day Out events in February. We made plans for Bible month events in the North and South. We got together for team meetings, mostly in Lampeter, and took time together to share in fellowship over a Christmas lunch

That seems a long time ago now. From March onward, with the change in priorities brought about by lockdown and the closure of MCH and Cliff College, all our work went on line. Whilst some things, like planning meetings and stewards training, MBTI and WLP tutor meetings and moderation, swapped easily into the world of Zoom, other things were cancelled and put on hold or completely rearranged. Connexionally, the Learning Network is currently devising or rewriting six training programmes to enable them to be delivered online, in blended or standalone units. Each of us in the Cymru Wales team are part of this process, and we are working closely with colleagues whom we used to see only rarely, but now often meet with on a weekly basis. Gareth led us on our Zoom with a Brew sessions, helping people across both Synods adjust to the new technology. We hastily organised the Unconscious Bias training mandated by Conference for all Circuit Invitation committees, and reached over 100 people in sessions over the summer,

### Y Cyngor – report for Synod Report book 2020

Y Cyngor is the body on which Methodists from the 2 Synods in Wales confer together. It has responsibility for 'co-ordination of overall mission and training strategies in Wales', 'oversight and co-ordination of ecumenical strategy, policy and relationships in Wales in line with connexional policy' and 'authorisation of representatives to speak with ecumenical partners and government.' (SO 491(3))

The Chair (Y Llywydd) of Y Gymanfa is Deacon Gwenllian Roberts Knighton and we are grateful for her gracious efficiency in undertaking this role. We normally meet 3 times (in November, March and June) at the Gateway Centre in Shrewsbury, but our March meeting took place just before the coronavirus lockdown and our June meeting was postponed. Meetings normally take the following pattern:

However, the most significant aspect of Y Cyngor's work over this last year continues to be its monitoring of the conversations between the 2 Synods in Wales, which have resumed following Synod Cymru's mission audit and subsequent proposals. These were initially planned to come before Synod Cymru in May, but because of the Coronavirus were then postponed to its meeting in November 2020. At this meeting Synod Cymru agreed to proposals which would involve its ceasing to be a Synod and looking to come as a Welsh-speaking circuit into a new Wales Synod. It was this decision which was shared and discussed at a bilingual Zoom meeting of Y Cyngor's Zoom later in November, while a smaller group of officers from both Synods are meeting with connexional representatives to explore in more detail what might be future proposals to come before both Synods.

The number of preachers has declined, as has the number of churches within the Synod. Now 171, previously 178. However, we are still accrediting new preachers, which is encouraging.

### **Christian Aid**

The Methodist Church has a place on the Christian Aid National Committee. Iy has been my privilege to have filled that place for some 20 years.

As with most Charities because of the Pandemic, there has been a marked decline in income. This has had an effect on the structure of the work in Wales. On the 3<sup>rd</sup> February, a meeting was held at Coleg Trefeca, where a radical plan to restructure was unveiled. From now on the Offices in Carmarthen and Bangor will close, many staff will work from home and the main hub of operations will be from the Cardiff Office. A virtual meeting was held on 3<sup>rd</sup> November. The latest information was that the target for income from Christian Aid Week for the whole of the UK was £7.1 million. The actual sum received was £3.7 million. However, the organisation continues to be determined to protest on behalf of the poor and disadvantaged. A letter has been sent to the Chancellor advocating that the debt owed by the 3<sup>rd</sup> World would be cancelled. Also, at the Glasgow Conference on Climate Change, Christian Aid will protest on Climate Justice.

The Christmas Appeal 2020 will concentrate on Ethiopia where the drought has decimated harvests and Christian Aid with its partners have undertaken the task of constructing deeper and newer wells.

The year got off to an excellent start with the (packed) welcome service in the village hall in Llangynin, St Clears for Deacon Jon Miller. Jon began a pioneering appointment working half time planting new Christian communities in St Clears and with the other half of his appointment as Momentwm Deacon, supporting and advocating for young people and youth work across the Synod. The Momentwm Deacon part of his appointment is a joint project (and funded) between Synod Cymru and the Wales Synod. Jon works closely and is guided by Momentwm Core and alongside this he has a reference group which includes, amongst others, both Synod Chairs. Jon visited a number of circuits in the first half of the year, including leading youth services, and taking a pivotal role in a day for youth workers in the Cardiff Circuit.

Momentwm Core planned, as usual, for many live events during this year including the Big Day Out, Momentwm Camp and the outward leg of an exchange to the United States. Unfortunately, because of the pandemic, the only live event which actually took place was the Big Day Out in February. This was held in two locations: Ty Bach Methodist Church, Port Talbot in the south and Trinity Methodist Church, Prestatyn in the north with over 70 young people attending between the two sites.

The Vice President Clive Marsh joined us in the south at where a number of workshops on the theme of 'Where's God in my story?' were taking place. We were also pleased to welcome students from Cliff College who not only led us in our opening devotions but also brought 'The Story Project' booth with them. Those who attended were encouraged to share about where God features in their story – and many did. In the South the day finished with a few hours in Limitless trampoline park.

In the North the day started at Rhyl's Ninja Tag Assault course later heading to Trinity where a wonderful warm welcome and a hot lunch awaited, after which everyone dived into the workshops. Leading on from the morning activity Ninja Warrior and Total Wipeout Contestant Rev Robin Fox told his story as a competitor and a Christian. Also, the president of Conference Rev Barbara Glasson was warmly welcomed to the event. It was lovely to hear afterwards how much Barbara and Clive had enjoyed their time with us.

When the pandemic hit Mometwm Core continued to find ways to support youth work and encourage the young people. ### Synod Enabler (Ethnic Minority Congregations)

This year has been a difficult one with many ups and downs but by the Grace of God, His work still continues. As a Synod Enabler with Culturally Diverse Congregations Wales, I am sharing this report with all of you as a reflection of how God has used me for his work throughout Wales over the past year. Working in this role for the past 12 years has been a great honour and privilege for me to be able to be a witness of God and a faithful servant working amongst people from all nations, cultures and backgrounds.

My job role consists of four key areas of work:

- 1. Work with asylum seekers and refugees
- 2. Work with culturally diverse congregations
- 3. Advocacy role across Synod

### Leading of worship

As mentioned above, the first key area of work for me is working amongst asylum seekers and refugees. Over the past year I have continued to provide support to those individuals and families who are going through tough times in their lives and the Lord has used me to help them in many ways. Through emotional support, guidance on their procedures, guidance on how to become better citizens in this country and showing them the abundant love of Christ. I would like to thank all the volunteers and other organisations that I work with or am affiliated with, who help me to be able to provide asylum seekers and refugees with household items and clothing - especially during the winter season.

The second area of work, working with culturally diverse congregations has again for another year been a very special and fruitful year for me. The Urdu/Hindi Fellowships in Cardiff and Swansea continue to grow, with people from Haverfordwest now joining us in Swansea. This year we celebrated our 12th anniversary in Cardiff and 5th anniversary in Swansea. I am continuing to provide support to other language fellowships also, including the Malayalam Fellowship (South Indian) and Ethiopian Orthodox Church, both of which worship at Trinity Centre Cardiff. My third key area of work is the advocacy role across the synod. I continue to preach within the Cardiff circuit and I am in contact with different circuits where ethinic people live.

Finally, leading worship is my fourth key role but due to the COVID-19 pandemic, over the past year, it has been a slight challenge in terms of travelling throughout Wales to lead worship in different circuits as I usually did before. However, I have been leading church services online every sunday throughout the year on Facebook and Zoom. Along with Sunday services, I have also been leading midweek prayer meetings on Zoom for the Urdu/Hindi Fellowships. In midweek services, I spend time leading worship with individual families and also as a congregation. In May of this year, I also organised a 24 hour prayer chain through Zoom in which we prayed for the world, COVID-19 and those who have been affected by the pandemic.

#### Synod Sabbaticals Report 2020

Spring and early summer are very popular choices when presbyters are planning their sabbatical leave and extended travel often forms a major part of sabbatical plans. The Sabbatical Prospectuses for the Connexional year 2019-20 were no different in this respect. However, the arrival of the coronavirus has made a huge dent in all but one of the seven Wales Synod sabbaticals originally planned for the spring and summer of this year, as plans were completely overturned by the pandemic and its associated restrictions on travel and communal activities. In some cases it has been possible to postpone activities until they can be realised in a future annual leave when travel will be easier; I am pleased to report that the Connexion has been willing to honour the Sabbatical financial support for such postponed activities. However, not all plans have been able to be salvaged. It has been possible to postpone part of the Sabbatical in a very few circumstances, but the fact that a new cohort of sabbaticals become due every year has meant that this could not be the solution for most of the 2019/20 recipients.

I am full of admiration for the pragmatism, forbearance and ingenuity that presbyters have shown, when confronted with a three months' Sabbatical at home, for the most part, in Lockdown. I note also that plans for the year 2020/21 are being re-focused more on investigative study and reflection, since the path out of the restrictions is by no means clear yet.

At the end of a sabbatical, each presbyter is asked to write a short report on their sabbatical experience and I get to read the reports as they come to me on their way to the Synod Policy Committee. This year's reports have been no less inspirational and enlightening. We currently share these reports with members of the Synod Policy Committee but I often wonder if a way could be found to publish Sabbatical Reports more widely within the Wales Synod, with the consent of the authors of course.

As Sabbaticals Officer for the Wales Synod I feel privileged to be able to help in facilitating such a precious gift to each presbyter from the Methodist Connexion. I look forward to the time when presbyters will once again be able to extend their horizons fully through their sabbatical experience.

### Cardiff University Methodist Chaplaincy Report 2019-2020

As I write, we are in the midst of the pandemic so it is hard to look back to September 2019 to the first event of the year when I took a bunch of students out for pancakes and ice cream after a Sunday church service! Where is the social distancing?!!

That first semester, we were oblivious to the impending pandemic as we crammed over 40 students in at a time for the £1 Curry lunch (serving over 70 in total each week). We held regular worship in the chapel (Monday Taizé services, Wednesday Contemplation and Communion, amongst

others) and themed our Monday night events around the Methodist theme for the year, "So, what's the story?" exploring the story of faith through Godly Play and talks from Cardiff Circuit Methodists Dave Kitchen on poetry, and Sarah Middleton on the Methodist Art

Collection. I met students and staff to give pastoral support, having a greater number of bereaved students than usual probably because of the introduction of 'Death Cafe' at the chaplaincy which showed we were able to support folks in grief. I was delighted to mentor one of the students as she began her Local Preacher's studies.

The first term passed with its usual Remembrance Day event, and Carols around the Tree at Christmas and the second semester started, our Monday nights turning to the theme of lent with excellent talks from university academics. With lockdown looming, the University asked staff to work from home from Tuesday 17th March so, of course, we cancelled our remaining events including the lent course, the £1 lunches and all worship events.

It was a strange end to the academic year - a few students popped in to say goodbye on that Monday and Tuesday, recognising that, as 3rd years, they probably wouldn't be back. I have worked from home from Wednesday 18th March. Despite the approaching Easter Holidays, we felt it important to keep in contact with those who had engaged with the Chaplaincy, so every week, from March 30th, we have held a zoom midday prayer, followed by a chat BYO drink drop-in. We have also started our Monday evening socials by Zoom, doing crazy quizzes, Pictionary and charades.

I have been in contact with all our students via social media and have had one-toone pastoral conversations via Zoom. Some of our students are still in Cardiff, others at home. Both present different challenges for students - isolation in Cardiff and living as adults at home with parents!

Graduation didn't happen as normal and although the university did its best to make a virtual graduation meaningful it was very sad not to have the grand pomp and

ceremony of a graduation as the means of saying goodbye to our students. The next academic year is going to be very challenging for us all, not least for our students who will continue their learning with very little face to face teaching and most of their course online. As chaplains, we will be reaching out to the students virtually, rather than in person, which makes the role of chaplaincy all the much harder. The prayers and support of the Synod are invaluable to this ministry as I seek to work out what it is to be a chaplain to Cardiff University in this strange new world of a pandemic.
